# **DEGREES AND CERTIFICATES**

The Pre-Law advising track is not a degree program at Minnesota State Mankato but is a course of study within the University for students seeking to pursue admission into law school.

#### What major should I choose if I want to go to law school?

Any major! The most important consideration when choosing a major is to choose a major you are interested in and know you can get good grades in. The most common major for going into law school is Political Science, but law schools will accept applications from any major.

#### ABOUT THE PROGRAM

A student's grade point average and Law School Admission Test score are the primary factors on which law schools base their admission decisions. Law schools generally do not require a particular major field or any particular prescribed courses as a prerequisite for admission. Most law schools merely require a bachelor's degree.

Advisors play an important role in guiding the students enrolled in such a plan of study, so students are urged to contact their advisor before enrolling.
